2022-2023 Instructions for Completing the FAFSA

Step 1

 Create a Federal Student Aid ID (FSA ID) for use throughout the Federal Aid process during and after college on the U.S. Department of Education's website at <u>https://studentaid.gov/fsa-id/create-account/launch</u>.
 You and one parent will each need an FSA ID and Password.

Step 2

• Once the FSA ID has been created, gather both student and custodial parent(s) Federal Tax Returns and W2 forms for 2020. You and your parent(s) 2020 Income and Asset information will also be used to complete your FAFSA application.

Step 3

 Beginning October 1, 2021, log on to <u>studentaid.gov</u> to complete the 2022-2023 Free Application for Federal Student Aid (FAFSA).

***Please Note- studentaid.gov is NOT compatible with Internet Explorer. You must use Chrome, Firefox or Safari Web Browser. ***

- Click on Apply for Aid and select 'Complete the FAFSA Form'
 If you are new to the FAFSA process click 'Start Here' under 'New to the FAFSA Process?'
 If you are a Returning User click 'Login' under 'Returning User?'
 - o Click 'I am a student and want to access the FAFSA Form' and click 'Log In to Continue'
 - Enter your FSA ID/Username and Password
 - Read the disclaimer then click 'Accept'
 - Click 'I am a student and want to access the FAFSA Form' and click 'Continue'
 - Click 'Start 2022-2023 FAFSA Form'
 - Create a save key and click 'Next'
 - An Introduction page to FAFSA will display, click 'Next'
- Answer all questions for Student Demographics, School Selection, Dependency Status, Parent Demographics, Parent Financials, and Student Financials. Be sure to use the **IRS Data Retrieval Tool** when completing the Parent Financials and Student Financials sections. This will allow parent(s) and students to transfer their processed Income Tax information to the FAFSA and satisfy some income verification requirements.

If a parent or student is not eligible to use the Data Retrieval Tool, the student and the parent will need to request a 2020 Tax Return Transcript from the IRS directly, at <u>irs.gov</u>.

- In the school selection section, select Fisher College's Federal School Code of 002150, so a copy of your information is electronically sent to the school and the Office of Financial Aid can process eligibility for assistance. THE <u>PRIORITY</u> <u>FUNDING DEADLINE</u> FOR FISHER COLLEGE IS MARCH 1, 2022.
 Note: for <u>Massachusetts Residents</u> the FAFSA filing deadline is May 1, 2022.
- At the completion of the FAFSA questions, review/print the summary page and proceed to the **'Sign and Submit'** page. You/your parent will be asked to electronically sign the FAFSA using your **FSA ID and Password**. Print the confirmation page for your records.
- Complete and submit any documents the Financial Aid Office may need to determine your eligibility for Financial Aid. Letters outlining additional information needed to complete your file will be sent to the student's home address.
- **PLEASE NOTE:** New students will be reviewed for their Financial Aid eligibility **after** they have been accepted to Fisher College and a valid FAFSA is on file.
